Subject: Unscheduled Interchange (UI) energy account (Deviation charges) for the week from **31.03.2014 to 06.04.2014** (Week No. **53**, Revision **1**).

Sir,

The Revised Unscheduled Interchange (UI) energy account (Deviation charges) for the week from **31.03.2014 to 06.04.2014** is enclosed herewith along with day wise statement of UI/deviation energy and corresponding charges computed in accordance with order no.3 of 2006 & amendments/orders issued by GERC with effective from 5th April'2010. As per GERC order: GERC/Legal/2015/436 dated 05th March'2015, revised UI/Deviation charges and volume of limits as specified by CERC in DSM regulations 2014 and same is made effective from 17th February'2014 and Deviation charges received from WRLDC towards power exchange with Gujarat transmission network which includes additional charges is pooled and shared through pool accounting.

Further, UI charges reduced due to Additional charges, capping of UI charges and token penalty at the frequency above 50.10Hz is also pooled and shared through Intra State UI pool account.

In accordance with clause 5 of complimentary commercial mechanism of Amendment order no.3 of 2010 issued by GERC, Payment of UI(Deviation) charges shall have a high priority and the concerned constituents/pool members shall pay the indicated amounts within 10 (ten) days of the statement issue into a state UI pool account operated by the SLDC. In the event of delay in realizing payment, simple interest of 0.04% for each day of delay would be recovered as per aforesaid order.

UI account is revised on account of:

- 1. As per GERC order No: GERC/Legal/2015/436 dtd 05th March'15 i.e. CERC DSM regulation 2014 is made effective from 17th February'2014 for intra state UI account.**
- 2. Correction in schedule calculation of DISCOMs, GIPCL-1.**
- 3. Incorporate of WR revision is done on dtd. 27.02.15.**

General Notes on UI (Deviation) Account for the Week
From 31.03.2014 to 06.04.2014

In accordance with Hon'ble GERC order vides letter GERC/Legal/2015/436 dated 05th March'2015 and CERC DSM Regulations 2014, Charges for the Deviation (UI) have been considered as under:

Sr.	Average Frequency of time Block(Hz)	UI/Deviation Rate(Paise/kwh)
I	50.05 HZ and above	000.00
II	Below 50.05 HZ and up to 50.00 HZ	178.00
III	Below 50.00 HZ and up to 49.70 HZ	803.20
IV	Below 49.70 HZ	824.04

- i. Charges for deviation for each 0.01 Hz step is equivalent to 35.60 Paise/kWh in the frequency range of 50.05-50.00 Hz.
- ii. Charges for deviation for each 0.01 Hz step is equivalent to 20.84 Paise/kWh in frequency range 'below 50 Hz' to 'below 49.70 Hz'.

Provided that,

- iii. The charges for the Deviation for the under draws by the buyer in a time block in excess of 12% of the schedule or 150 MW, whichever is less, shall be zero.
- iv. The charges for the Deviation for the over-injection by the seller in a time block in excess of 12% of the schedule or 150 MW, whichever is less, shall be zero, except in case of injection of infirm power.

1. Limits on Deviation volume and consequences of crossing limits:

- I. In addition to Charges for Deviation as stipulated under Regulation 5 of DSM regulations, Additional Charge for Deviation shall be applicable for over-drawal as well as under-injection of electricity for each time block in excess of the volume limit specified. when average grid frequency of the time block is "49.70 Hz and above" at the rates specified in the Table-I (A) below in line with CERC DSM Regulation 2014 dated 07th January'2014 and Corrigendum dated 17th February'2014.

TABLE –I (A)**When 12% of Schedule is less than or equal to 150 MW**

(i) For over drawal of electricity by any buyer in excess of 12% and up to 15% of the schedule in a time block.	Equivalent to 20% of the Charge for Deviation corresponding to average grid frequency of the time block.
(ii) For over drawal of electricity by any buyer in excess of 15 % and up to 20% of the schedule in a time block.	Equivalent to 40% of the Charge for Deviation corresponding to average grid frequency of the time block.
(iii) For over drawal of electricity by any buyer in excess of 20 % of the schedule in a time block.	Equivalent to 100% of the Charge for Deviation corresponding to average grid frequency of the time block.
(iv) For under injection of electricity by any seller in excess of 12% and up to 15% of the schedule in a time block.	Equivalent to 20% of the Charge for Deviation corresponding to average grid frequency of the time block.
(v) For under injection of electricity by any seller in excess of 15 % and up to 20% of the schedule in a time block.	Equivalent to 40% of the Charge for Deviation corresponding to average grid frequency of the time block.
(vi) For under injection of electricity by any seller in excess of 20 % of the schedule in a time block.	Equivalent to 100% of the Charge for Deviation corresponding to average grid frequency of the time block.

When 12% of Schedule is more than 150 MW

(i) For over drawal of electricity by any buyer is above 150 MW and up to 200 MW in a time block.	Equivalent to 20% of the Charge for Deviation corresponding to average grid frequency of the time block.
(ii) For over drawal of electricity by any buyer is above 200 MW and up to 250 MW in a time block.	Equivalent to 40% of the Charge for Deviation corresponding to average grid frequency of the time block.
(iii) For over drawal of electricity by any buyer is above 250 MW in a time block.	Equivalent to 100% of the Charge for Deviation corresponding to average grid frequency of the time block.
(iv) For under injection of electricity by any seller is above 150 MW and up to 200 MW in a time block.	Equivalent to 20% of the Charge for Deviation corresponding to average grid frequency of the time block.
(v) For under injection of electricity by any seller is above 200 MW and up to 250 MW in a time block.	Equivalent to 40% of the Charge for Deviation corresponding to average grid frequency of the time block.
(vi) For under injection of electricity by any seller is above 250 MW in a time block.	Equivalent to 100% of the Charge for Deviation corresponding to average grid frequency of the time block.

- II. As per the CERC CORRIGENDUM dated 17th February'2014, in the notification No. L-1/132/2013-CERC, dated the 6th January, 2014 after Table-I (A) added the following "Provided further that when the schedule is less than 150 MW, the additional charges for deviation shall be based on percentage of deviation worked out with reference to schedule of 150 MW as per TABLE-I (A)"
- III. In addition to Charges for Deviation as stipulated, Additional Charge for Deviation shall be applicable for over-injection/under drawal of electricity for each time block by a seller/buyer as the case may be when grid frequency is "50.10 Hz and above" at the rates equivalent to charges of deviation corresponding to the grid frequency of "below 50.01 Hz but not below 50.0 Hz".

IV. In addition to Charges for Deviation as stipulated, Additional Charge for Deviation shall be applicable for over-drawal or under-injection of electricity when grid frequency is "below 49.70 Hz" and the same shall be equivalent to 100% of the Charge for Deviation of 824.04 Paise/kWh corresponding to the grid frequency of "below 49.70 Hz".
